Register to Vote!

You may register to vote if you are a citizen of the U.S. for at least 1 month before the next election, a resident of Pennsylvania and your election district for at least 30 days before the next election, and 18 years of age on the day of the next election.

You can register **in person** at your county voter registration office or at the Department of Transportation photo license centers.

You can register **by mail**. Voter registration mail applications are available at your county voter registration office and at other locations within each county including public libraries, universities, and through many service organizations.

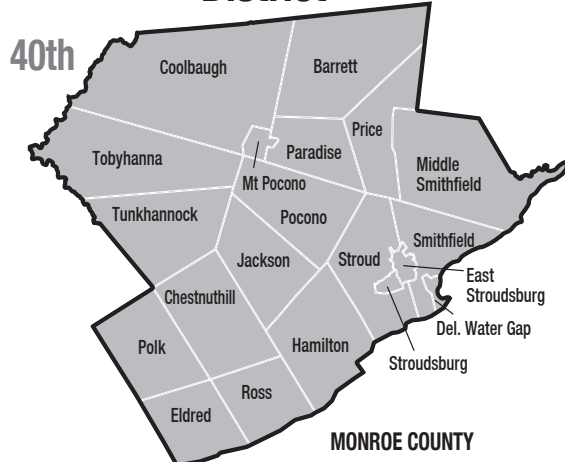

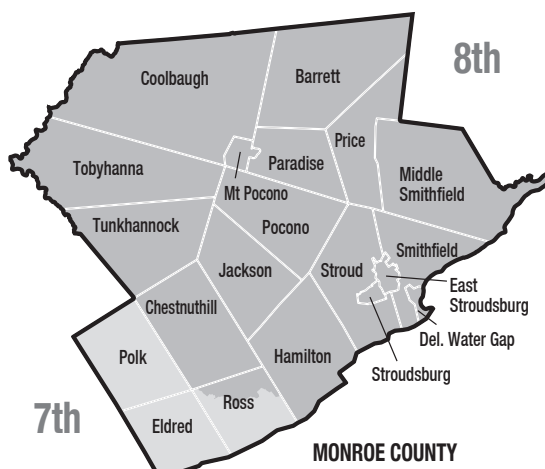

**State Senate District**



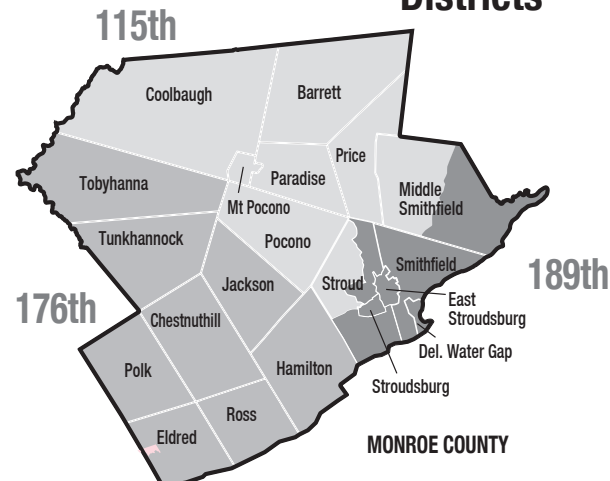

**BE AN ACTIVE PART OF YOUR GOVERNMENT**

**TIPS FOR COMMUNICATING WITH YOUR LEGISLATIVE REPRESENTATIVES**

Every elected official is sensitive to grass-root opinion. Your participation in government should not stop with your vote, but there's an art to communicating with your representative.

- Inform your legislator of your stand on the issues of particular interest to you —briefly and to the point.
- Refer to his/her position on the issues, if known.
- Thank him/her when he/she supports an issue of which you approve.
- Write promptly and plainly; a post card is acceptable.
- DON'T write too often to the same legislator during one session, even on different subjects.
- DON'T begin with "As a citizen and taxpayer," and
- DON'T apologize.
- DON'T write to legislators from another district.
- DON'T be discouraged by special interest lobbies.
